

Privacy Policy

DataProtect Group LLC is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the DataProtect Group LLC Web site and governs data collection and usage. By using the DataProtect Group LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

DataProtect Group LLC collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. DataProtect Group LLC also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by DataProtect Group LLC. Use of your Personal Information

DataProtect Group LLC collects and uses your personal information to operate the DataProtect Group LLC Web site and deliver the services you have requested. DataProtect Group LLC also uses your personally identifiable information to inform you of other products or services available from DataProtect Group LLC and its affiliates. DataProtect Group LLC may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

DataProtect Group LLC does not sell, rent or lease its customer lists to third parties. DataProtect Group LLC may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to DataProtect Group LLC, and they are required to maintain the confidentiality of your information.

DataProtect Group LLC does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

DataProtect Group LLC keeps track of the Web sites and pages our customers visit within DataProtect Group LLC, in order to determine what DataProtect Group LLC services are the most popular. This data is used to deliver customized content and advertising within DataProtect Group LLC to customers whose behavior indicates that they are interested in a particular subject area.

DataProtect Group LLC Web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on DataProtect Group LLC or the site; (b) protect and defend the rights or property of DataProtect Group LLC; and, (c) act under exigent circumstances to protect the personal safety of users of DataProtect Group LLC, or the public.

Use of Cookies

The DataProtect Group LLC Web site use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize DataProtect Group LLC pages, or register with DataProtect Group LLC site or services, a cookie helps DataProtect Group LLC to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
